Successful P3 procurement requires open discourses with prospective bidders and the private partner ultimately awarded the project. Both the public and private sector partners freely participate in design concepts, usage projections and requirements, financial forecasting and modeling, and other aspects of the facility in which they will partner. But this process can only be successful if the public sector understands the industry in which they are about to engage. Many P3s combine traditional public facilities with mixed use, hotels, residences, offices and other income-generating uses. The public sector is usually not involved in those markets, making it important for the public sector to familiarize itself with those markets, so the expectations and valuations of the project are aligned between the public and private sectors during procurement. This panel will discuss the importance of this and suggest ways to implement it properly. It will also discuss what can go wrong if it is not properly implemented.

Contract terms and risk management are two of the most critical elements of P3 making it extremely important for all parties to understand the roles and responsibilities before contracts are signed. This includes establishing reasonable expectations that are practical and achievable; understanding risks; and determining how the participants will identify, discuss and resolve the question of risk allocation. Although significant consideration and planning is given to design, constructability, performance and finance, things can quickly go awry if the associated risks are not understood or accounted for. There is great disparity across the industry related to the limits of liability for all parties involved should project risks become a reality. The objective of this session is to provide a platform for open dialogue among industry leaders with a focus on best practices for contract terms and conditions, and limit of liability.
